1. Subjects of the treatment

2. Source of personal data

5. Categories of recipients

The Data provided by the user and/or collected through the Site, for the purposes described, may be brought to the attention of the following subjects:

- employees and collaborators who act under the authority of the Data Controller and who are authorized to process them as persons authorized to process them and have received instructions regarding the processing of data;
- third parties to whom the Data Controller entrusts certain processing activities and who consequently carry out activities and services related to the processing and the purposes described on behalf of the same (for example, companies and institutions in the credit sector, administrative, accounting, tax, auditing services, hosting providers, IT service companies, information system management, credit collection, mass archiving, sending online communications, user support, subjects in charge of home delivery, etc.).
